Resolution:

BE IT RESOLVED, that the Board of Trustees of Michigan State University hereby authorizes the Administration to negotiate and enter into a lease for space in the City of Lansing for a long-term lease and upon such other terms and conditions as may be acceptable to the President or designee.

The Trustee Committee on Budget and Finance recommends that the Board of Trustees authorize the Administration to enter into a lease for space in the City of Lansing for the purposes of establishing a Child Development Laboratory.

Summary:

- The Child Development Lab (CDL) received \$2,187,500 in congressional funding to expand CDL facilities and outreach, as well as State of Michigan SFY26 \$2,000,000 appropriation.
- The property in the City of Lansing meets criteria for location, size, and space plan/build-out to meet the programmatic needs of the CDL and serve the Lansing community.

Background Information:

Michigan State University's Child Development Laboratory is a function within the College of Social Science/Department of Human Development and Family Studies. The CDL is open to the public, offering full-day preschool programs for children ages birth to kindergarten. The CDL mission includes:

- Outstanding service to children and their families (community outreach).
- Exemplary setting for training undergraduate and graduate students in early childhood education best practices (university teaching).
- Research laboratory for MSU faculty and students (research).
- Networking and outreach to other early childhood professionals (professional outreach).

The CDL currently has sites in East Lansing and Haslett. Congressional funding was sought to start a CDL in Lansing, Michigan to respond to demand for quality care for children ages birth to kindergarten. The Lansing site would help children most at risk within the community and provide capacity to educate additional teachers, in response to the state-wide teacher shortage. The Lansing site will create opportunities for community outreach and engagement, support local economic development, and increase MSU presence in the City of Lansing.

The authorization of this resolution will allow MSU to lease space for the Child Development Lab in the City of Lansing. It is anticipated that the lease will be for approximately 15,000 square feet. The lease costs will be funded by a combination of external, College of Social Science, Department of Human Development and Family Studies/Child Development Lab, Provost and other potential grant funds.
